

PRIVACY POLICY

1. I respect your privacy:

- a. I respect your right to privacy and am committed to safeguarding the privacy of my customers and website visitors. This policy sets out how I collect and treat your personal information.
- b. I adhere to the Australian Privacy Principles contained in the *Privacy Act 1988* (Cth) and to the extent applicable, the EU General Data Protection Regulation (GDPR).
- c. "Personal information" is information I hold which is identifiable as being about you. This includes information such as your name, email address, identification number, or any other type of information that can reasonably identify an individual, either directly or indirectly.
- d. You may contact me in writing at ceremonieswithhaylie@gmail.com for further information about this Privacy Policy.

2. What personal information is collected:

- a. I will, from time to time, receive and store personal information you submit to my website, provide to me directly or give to me in other forms.
- b. You may provide basic information such as your name, phone number, address, and email address to enable me to send you information, provide updates and process your product or service order.
- c. I may collect additional information at other times, including but not limited to, when you provide feedback, when you provide information about your personal or business affairs, change your contact or email preference, respond to surveys and/or promotions.
- d. Additionally, I may also collect any other information you provide while interacting with me.
- e. I do not hold any financial information that belongs to you; however, you should be aware that you may be providing financial information to a third party billing service to whom you may be directed at the time of agreeing to a service or purchasing a product on my website. Please ensure that you have thoroughly read their terms and conditions prior to the use of their services, as information provided to a third party is subject to their terms and conditions and not these.

3. How I collect your personal information:

- a. I collect personal information from you in a variety of ways, including when you interact with me electronically or in person, when you access my website and when

I engage in business activities with you. I may receive personal information from third parties. If I do, I will protect it as set out in this Privacy Policy.

- b. By providing me with personal information, you consent to the supply of that information subject to the terms of this Privacy Policy.

4. How I use your personal information:

- c. I may use personal information collected from you to provide you with information about my products or services. I may also make you aware of new and additional products, services, and opportunities available to you.
- d. I will use personal information only for the purposes that you consent to. This may include to:
 - i. provide you with products and services during the usual course of my business activities;
 - ii. administer my business activities;
 - iii. manage, research and develop my products and services;
 - iv. provide you with information about my products and services;
 - v. communicate with you by a variety of measures including, but not limited to, telephone, email, SMS or mail; and
 - vi. investigate any complaints.
- e. If you withhold your personal information, it may not be possible for me to provide you with our products and services or for you to fully access my website.
- f. I may disclose your personal information to comply with a legal requirement, such as a law, regulation, court order, subpoena, warrant, legal proceedings or in response to a law enforcement agency request.
- g. If there is a change of control in my business or a sale or transfer of business assets, I reserve the right to transfer to the extent permissible at law my user databases, together with any personal information and non-personal information contained in those databases.

5. Disclosure of your personal information:

- a. I may disclose your personal information to any of my employees, officers, insurers, professional advisers, agents, suppliers, or subcontractors insofar as reasonably necessary for the purposes set out in this privacy policy.
- b. If I do disclose your personal information to a third party, I will protect it in accordance with this privacy policy.

6. Security of your personal information

- a. I am committed to ensuring that the information you provide to me is secure. To prevent unauthorised access or disclosure, I have put in place suitable physical, electronic and managerial procedures to safeguard and secure information and

protect it from misuse, interference, loss and unauthorised access, modification and disclosure.

- b. Where I employ data processors to process personal information on my behalf, I only do so on the basis that such data processors comply with the requirements under the relevant law and that have adequate technical measures in place to protect personal information against unauthorised use, loss, and theft.
- c. The transmission and exchange of information is carried out at your own risk. I cannot guarantee the security of any information that you transmit to me or receive from me. Although I take measures to safeguard against unauthorised disclosures of information, I cannot assure you that personal information that I collect will not be disclosed in a manner that is inconsistent with this privacy policy.

7. Access to your personal information:

- a. You may request details of personal information that I hold about you in accordance with the provisions of the *Privacy Act 1988* (Cth), and to the extent applicable to the EU GDPR. If you would like a copy of the information which I hold about you or believe that any information I hold on you is inaccurate, out of date, incomplete, irrelevant, or misleading, please email me at ceremonieswithhaylie@gmail.com.
- b. I reserve the right to refuse to provide you with information that I hold about you, in certain circumstances set out in the Privacy Act or any other applicable law.

8. Complaints about privacy:

- a. If you have any complaints about my privacy practices, please feel free to send in details of your complaints to ceremonieswithhaylie@gmail.com. I take complaints very seriously and will respond shortly after receiving written notice of your complaint.

9. Changes to Privacy Policy:

- a. Please be aware that I may change this Privacy Policy in the future. I may modify this Policy at any time, in my sole discretion and all modifications will be effective immediately upon my posting of the modifications on my website or notice board. Please check back from time to time to review my Privacy Policy.

10. Website

- a. *When you visit my website*
When you visit my website www.ceremonieswithhaylie.com.au I may collect certain information such as browser type, operating system, website visited immediately before coming to my site, etc. This information is used in an aggregated manner to analyse how people use my site, such that I can improve my service.
- b. *Third party sites*
My site may from time to time have links to other websites not owned or controlled by me. These links are meant for your convenience only. Links to third party

websites do not constitute sponsorship or endorsement or approval of these websites. Please be aware that I am not responsible for the privacy practices of other such websites. I encourage my users to be aware, when they leave my website, to read the privacy statements of each and every website that collects personal identifiable information.

11. Use of Cookies

c. *What is a Cookie?*

A cookie is a small piece of data that a website asks your browser to store on your computer or mobile device. The cookie allows the website to "remember" your actions or preferences over time. Most Internet browsers support cookies, however, users can set their browsers to decline certain types of cookies or specific cookies. Further, users can delete cookies at any time.

d. *Why do I use cookies?*

I use cookies to learn how you interact with my content and to improve your experience when visiting my website. For example, some cookies remember your language or preferences so that you do not have to repeatedly make these choices when you visit my website. I also use cookies to help me with geolocation tracking to present you with more relevant information. Additionally, cookies allow me to serve you specific content, such as videos on my website. I may employ the learnings of your behaviour on my website to serve you with targeted advertisements on third-party websites in an effort to "re-market" my products and services to you.

e. *What types of cookies do I use?*

(i) *First-Party and Third-Party Cookies* – I use both first-party and third-party cookies on our website. First-party cookies are cookies issued from my domain that are generally used to identify language and location preferences or render basic site functionality. Third-party cookies belong to and are managed by other parties, such as my service providers. These cookies may be required to render certain forms within my website.

(ii) *Session Cookies* - Session cookies are temporary cookies that are used to remember you during your visit to the website, and they expire when you close the web browser.

(iii) *Persistent Cookies* - Persistent cookies are used to remember your preferences within the website and remain on your desktop or mobile device even after you close your browser or restart your computer. I use these cookies to analyse user behaviour to establish visit patterns so that I can improve my website functionality for you and others who visit my website. These cookies also allow me to serve you with targeted advertising and measure the effectiveness of my site functionality and advertising.

f. *How are cookies used for advertising purposes?*

Cookies and ad technology such as web beacons, pixels, and anonymous ad network tags help me serve relevant ads to you more effectively. They also help me collect aggregated audit data, research, and performance reporting for advertisers. Pixels enable me to understand and improve the delivery of ads to you and know when certain ads have been shown to you. Since your web browser may request advertisements and web beacons directly from ad network servers, these networks can view, edit, or set their own cookies, just as if you had requested a web page from their site. Although I do not use cookies to create a profile of your browsing behaviour on third-party sites, I do use aggregate data from third parties to show you relevant, interest-based advertising. I do not provide any personal information that I collect to advertisers. You can opt out of off-site and third-party-informed advertising by adjusting your cookie settings. Opting out will not remove advertising from the pages you visit, but, instead, opting out will result in the ads you see not being matched to your interests. This implies that the ad(s) you see will not be matched to your interests by those specific cookies.

g. How are third party cookies used?

For some of the functions within my website I use third party suppliers, for example, when you visit a page with videos embedded from or links to YouTube. These videos or links (and any other content from third party suppliers) may contain third party cookies, and I encourage you to consult the privacy policies of these third party vendors on their websites for information regarding their use of cookies.

h. How do I reject and delete cookies?

You can choose to reject or block all or specific types of cookies set by virtue of your visit to my website by clicking on the cookie preferences on my website. You can change your preferences for my website and/or the websites of any third party suppliers by changing your browser settings. Please note that most browsers automatically accept cookies. Therefore, if you do not wish for cookies to be used, you may need to actively delete or block the cookies. If you reject the use of cookies, you will still be able to visit my website but some of the functions may not work correctly. By using my website without deleting or rejecting some or all cookies, you agree that I can place those cookies that you have not deleted or rejected on your device.
